Our organization has more than 15 years of experience embedding pharmacists in Ambulatory Services. The Gengras Internal Medicine Practice is the 1st hospital-based clinic in CT to receive national recognition as a Patient-centered Medical Home.

Pharmacy residents have the opportunity to practice at the top of their license while managing a wide spectrum of disease states. Rotation structures vary from an interdisciplinary team approach to independent medication management under collaborative drug therapy management agreements.

While required rotations offer a solid foundation in Ambulatory Care, the program also offers opportunities for growth in multiple specialties areas based on resident interest.

The Residency Program

Saint Francis Hospital and Medical Center established the PGY2 Ambulatory Care Pharmacy Residency in 2016. The goal of the program is to develop a competent ambulatory care practitioner capable of providing comprehensive, patient-centered care.

Pharmacists completing the program will:

- Develop skills to manage complex patients
- Reinforce leadership skills by precepting pharmacy students and PGY1 pharmacy residents
- Establish strong relationships with patients and healthcare professionals
- Qualify to take the BPS examination for Board Certification in Ambulatory Care



Qualifications:

- Completion of an ASHP-accredited PGY1 residency
- Eligible to attain licensure in the state of Connecticut by September 30 of the residency program year
